Safety Management System (SMS) is implemented all over the organization by a centralized department, the one that performs and coordinates all risk management, training, promotion, and surveillance of all SMS processes described in the airline SMS Manual.



















• Safety certifications:

- SMS Certificate by the Federal Civil Aviation Agency (AFAC) last audit May 2022.
- Flight Safety Foundation's (FSF) Basic Aviation Risk Standard (BARS) last audit Oct 2022.

 BARS program is designed to provide organizations that engage contracted aircraft operators with a standard to assist in the risk-based management of aviation activities.

 The BARS renewing audit was carried out in Oct 2022. All findings have now been closed. Soon the airline will receive the new certificate.
- TAR Aerolíneas was IOSA registered (Certificate from March 2019 March 2021). It was not renewed due the pandemic.
