I take this opportunity to explain the steps when becoming a new member:

1. **Registration Form:** Please fill and sign the registration form attached. Once received, we send an email to all the CEOs of the airlines member of ALTA about the interest that Sunoco has in becoming an Affiliate Member of ALTA. They make a vote, and the process takes around 10 days.
2. **Wire Transfer:** We will send you an email with the invoice for the 2024 membreship fee (October – December), for you to make the wire transfer.
